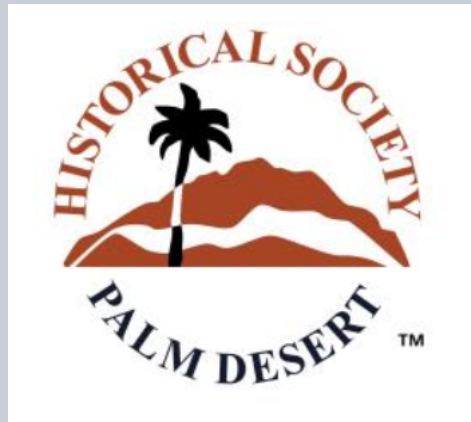

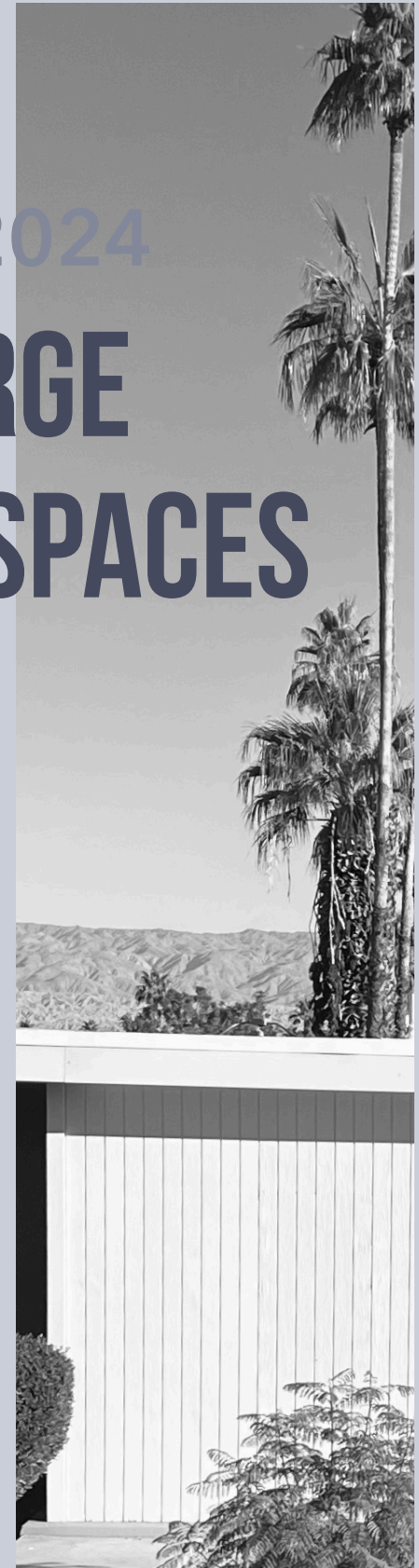

- #3: 46230 Shadow Mountain Dr (1959). Owned by Refa Deaton and built by Patten and Wild. Possibly designed by Ross Patten.
- #4: 72760 C Mesquite Ct. Kings Point, Cactus and Mesquite Courts (1974-76) architect Hugh M. Kaptur.
- #5: 45906 Shadow Mountain Dr (1958). Owned by L.W. Thompson and built by Patten & Wild, designed by Ross Patten.
- #6: 72821 Hedgehog St (1953). Although there is no documentation, has the attributes of a design by architect Walter S. White.
- #7: 72810 Hedgehog St (1952) Although there is no documentation, has the attributes of a design by architect Walter S. White.
- #8: 72787 Hedgehog St (1953) Designed by architect Walter S. White as part of the Palm Desert Corporation's Metro Homes.
- #9: 72759 Hedgehog St (1953) Designed by architect Walter S. White for Robert C. Morrey. This was part of the Palm Desert Corporation's Metro Homes.
- #10: 72705 Hedgehog St (1951) Designed by architect Walter S. White as part of the Palm Desert Corporation's Metro Homes.
- #11: 72707 Hedgehog St (1960) Owned and built by Patten & Wild, and designed by Ross Patten.
- #12: 72603 Hedgehog St (1958) Designed by architect Walter S. White for David Swenson. This was part of the Palm Desert Corporation's Metro Homes.
- #13: 1316 Sandpiper. William Krisel architect. Sandpiper consists of 17 circles.
- #14: 72476 Pitahaya St (1964) Designed and built by architect John P. Moyer, most likely under his company El Toro Development.
- #15: 72579 Beavertail St (1962) Designed by architect John P. Moyer.
- #16: 72637 Beavertail St (1960) Designed and built by architect John P. Moyer under his company El Toro Development.
- #17: 72763 Beavertail St (1957) Designed by architect Walter S. White.
- #18: 45666 Shadow Mountain Dr (1957) Designed by architect Walter S. White for Charles Gibbs.
- #19: 72629 Pitahaya St (1962) Designed and built by architect John P. Moyer, most likely under his company El Toro Development.
- #20: 72550 Pitahaya St (1962) Designed and built by architect John P. Moyer under his company El Toro Development.
- #21: 72564 Pitahaya St (1962) Designed and built by architect John P. Moyer under his company El Toro Development.
- #22: 45710 Shadow Mountain Dr (1953) Designed by architect Walter S. White for Charles Gibbs.
- #23: 46143 Highway 74 (1963) Sands and Shadows condominiums designed by architect Harold J. Bissner and Robert Pitchford and developed by Neil Davis. This was the second phase.
- #24: 46183 Highway 74 (1960) Sands and Shadows condominiums designed by architect Harold J. Bissner and developed by Neil Davis. This was the first phase.
