


It is interesting that despite the cold weather, everyone really enjoyed the get together.





Obituaries Notable Palm Desert lives remembered

JOHN WASHINGTON MARZICOLA

John Washington Marzicola, 94, a resident of Rancho Mirage, passed away on June 12, 2012, after a brief illness.

He was born, in Chicago, IL, the eldest of four children, to Italian immigrant parents, Oreste and Carlotta Marzicola.

John was preceded in death by his beloved wife of 46 years, Patricia. He is survived by by a brother, George, also of Rancho Mirage, and five children from a former marriage to Jean Krouse Marzicola and their spouses: John, Steven (Maria) Jo Ann (John), Linda (Tim), Laurie (Kevin), twelve grandchildren and seventeen great grandchildren.

John graduated from Austin High School in Chicago in 1936, served in the Army Air Corps for seventeen months. He attended U of Illinois until being offered a position in San Diego in 1942 as an aviation stress analyst for Consolidated Vultee Aircraft.

In 1945 he built houses for a brief time. In 1952 he joined Zenith plastics, where he was Senior Project Engineer for the design of plastic hull Aircraft in Culver City. During this time he received his B.S. and M.S. degrees in Mechanical Engineering from USC. He then taught engineering and math at COD.

John was a sociable and civi-minded fellow, and all who knew him found that his associates soon became his friends. John was president of the board for Harvest Wellness Foundation, Good Neighbors of the Desert, regional Director of United Good Neighbors of the Desert, and an active Rotarian. He leaves behind many friends who will miss his keen mind, his easy laugh, and his love of life.

HSPD Art Events

The Historical Society is becoming known as a center for desert art. That reputation was reinforced on Saturday, April 14th, as the HSPD again hosted Appraisal Day with Kevin Stewart and with Howard Schepp joining the event this year. The event was a presentation in cooperation with Desertscapes, the valley wide arts celebration hosted by the City of Palm Desert and other organizations.

Since the appraisal events began two years ago, there's always a waiting list for members and others to have their treasures evaluated. On a cool morning with new snow on the hills, there was an Antiques Roadshow excitement in the air as guests lined up with their mystery items. The appraisers could not be stumped, no matter what was placed before them --- including an antique doll, a bear jaw knife and a desert painting by the early botanist Edith Purer—among dozens of disparate items.

After the appraisals wound up, guests crowded into the back room as first-time curators Harry Quinn and Sandra Craig presented a new exhibit on early desert painters Jimmy Swinnerton and Bill Bender.

Another new exhibit opening the same day featured five contemporary painters who are leading a renaissance of desert art—Elaine Mathews, Terry Masters, Lisa Spencer, Jim Toenjes and Andrew Gillespie. On crutches due to a recent golf accident, Terry Masters was determined to give his painting demo despite pain—a testament to the indomitable spirit of the Smoketree School of desert painters past and present.
